Treasurer Harrig's report: A New Bridge account was set up for earmarked funds

Cash on hand August 2017 \$682,766.66

Income \$50,744.41

Expenses \$118,285.72

Available balance \$615,225.35

Motion was made to make Budget adjustment as needed, moving funds from account 602010 to accounts 600006, 601001, 601006, 601007, 601012, 601016, 602010, 612700, and 613500. Motion carried.

New bonding requirements for the treasurer are covered with our ordinance under chapter 100

Rescue Squad Report: There was no meeting held, next meeting will be November 27, 2017

Fire Dept. Report: The meeting was held on October 24, 2017, the current number of fire calls stands at 169 with last years at 114. The fire department has adopted the bylaw changes. Engine 1112 went through pump testing and passed, but while testing was performed the engine block cracked, Grant fire department was interested in buying the truck will still pursue and see if they can still sell the truck. 2% dues were discussed and the department will establish accounts for each municipalities 2% dues.

The fire call bill on Oakhill Dr. was discussed and the owner of the property now understands the bill and knows that it will appear as a special assessment on his property taxes.

Community Park: Burn out damage was discussed, will look for restitution for repairs of the vandalism

Humane officer report: Tauscher/Deneys, motion to receive and place on file the report from the humane officer. Motion carried. Discussion was held about a possible contract with Bay Area Humane Society; Monica will present the contract to the BAHS.
