The Town Board of Pittsfield held a regular board meeting on Tuesday, November 14, 2014. Chairman Deneys called the meeting to order at 7:10 p.m. followed by the Pledge of Allegiance and an opening prayer. Present for roll were Chairman Deneys, Supervisor Huetter, and Supervisor Tauscher.

Tauscher/Huetter, motion to approve the printed agenda. Motion carried.

Huetter/Deneys, motion to approve the minutes of the October 14, 21, 29, 2014 meetings. Motion carried.

Public comments; Betty Huetter asked about the used tires collecting at the town hall. Dean Freeberg reported Scenic Valley Nursery will take yard waste. Tom Steinburecker reported a speeding problem on Westline.

Tauscher/Huetter, motion to accept the report. Motion carried.

Rescue Squad Report:

No meeting in October. Next meeting will be Nov. 17, 2014.

Fire Dept. Report:

No meeting in October. Next meeting will be Nov. 25, 2014, at which time the by-laws will be discussed.

Deneys/Huetter, motion to accept and file the report from the humane officer. Motion carried.

Planning committee report:

1. Recommend approval for a tile line to cross Golden Rod Dr.
2. Implements of husbandry, recommend adoption of option "F".
3. Farmland preservation map was reviewed. Three parcels on Town Hall Drive have been incorrectly zoned out of Exclusive Ag. Chairman advised to send a letter to the county requesting a correction and information on course of action being planned .
4. Community Park is seeking donations to help with future development.
5. Draft copies of the General Code codification were passed out to committee member who are asked to review the first 10 pages before the Dec. 2014 meeting.
6. State regulations will be followed regarding the use of rifles in the town.

Tauscher/Huetter, motion to approve the committee report. Motion carried.

Roads:

1. Repairs to Glendale Ave. from the Mountain Bay Trail to Greenfield will be put on as an option when bidding work for Westline.

2. A joint meeting with Suamico will be set up for mid December for an overall presentation of the Westline project and to answer questions.
3. Permits have been applied for to begin the replacement of the bridge on Kunesh North Road. Project is projected for replacement in January 2015. A special board meeting will be scheduled for Nov. 18, 2014, 6:30 p.m. to sign a contract for the work.

Huetter/Tauscher, motion to allow a tile line to be installed across Golden Rod Dr. and have the area restored to its current condition. Motion carried.

Deneys/Tauscher, motion to contract with Brandon Holewinski for mowing of the town hall yard, North Pittsfield Cemetery, and the Community Park. Motion carried.

Town board is looking at options to conduct a Municipal Court as the Pulaski area court will terminate effective May 1, 2015.

Deneys/Tauscher, motion to have the town retain management of cell tower lease. Motion carried.

Budget items were reviewed. Hearing is scheduled for Dec. 1, 2014, at 6:00 p.m.

Huetter/Tauscher, motion to approve permits issued by the building inspector and the zoning administrator. Motion carried.

Deneys/Tauscher, motion to approve checks 10843-10897. Motion carried.

Huetter/Tauscher, motion to adjourn at 9:30 p.m. Motion carried.
