Huetter/Tauscher, motion to approve the agenda as printed. Motion carried.

Rescue Squad Report:

Planning committee report:

2. Recommend the board proceed to get information and bids for community garbage collection.
3. Zoning administrator report a court date of June 4, 2015 has been set regarding the hybrid dogs located on Anston Road. Information regarding homing pigeons in an R-2 zone will be reviewed. Deneys/Huetter, motion to accept the report. Motion carried.

Deneys/Tauscher, motion to approve a post issuance compliancy policy for obligations. Voice vote: Deneys, yes, Huetter, yes, Tauscher, yes. Motion carried.

Road repairs and maintenance:

2. Pre-construction meeting for Westline will be held the week of May 18, 2015.
3. Property owner of the tile line crossing Quarry Drive will be billed for the repairs required.

5. Huetter/Deneys motion to contract with Crack Seal Specialist for up to \$10,000 of work. Motion carried.
6. Chairman Deneys will contact Matt Maroczak for mowing and spraying of ditches.
