Rescue Squad Report: All Municipalities were present, including the Town of Pittsfield's Chairman and the Tri county Fire Chief. The general fund is at \$16,669 and the equipment fund is at 61,989. Runs are at a total of 45 with Pittsfield having 6. 2019 budget is ahead of the budgeted amount so a refund for the Town of Pittsfield will be \$1,282.29, as voted on the town will need to refund back to NEW Rescue the amount of \$443.58 and the previously voted on \$3000 for the equipment fund. The billing policy for assistance from the Fire department to the NEW Rescue was discussed and a change in billing may help will the issue. Bob Eager was promoted to a supervisor. The next meeting will take place on March 23<sup>rd</sup> at 1PM.
