The Town Board of Pittsfield held a regular board meeting on Tuesday, March 10<sup>th</sup>, 2020. The meeting was called to order by Chairman Deneys at 6:50 p.m. followed by the Pledge of Allegiance and an Opening Prayer. Present for roll call were Chairman Deneys, Supervisor Huetter and Supervisor Bodart.

Deneys/Bodart, motion to approve and deviate from the agenda as needed. Motion carried.

Huetter/Bodart, motion to approve the minutes from the February 11<sup>th</sup> & 17<sup>th</sup>, 2020 Town Board meeting. Motion carried.

Public Comments: A Resident requested potholes filled on Anston Rd west of Sunnybrook. Also requested the town look into shouldering on some of the roads before the manure hauling season gets underway.

Rescue Squad Report: No Meeting was held, the next meeting will take place on March 23<sup>rd</sup> at 1PM.

Fire Dept. Report: The Fire department held the meeting on February 25<sup>th</sup>, 2020. The run report is at 19 runs compared to 22 for this same time period in 2019. The department has dropped 2 Members due to time limitations. The department updated their insurance, they got better coverage for less money. Howard is looking at a joint fire practice training session. Shawano and Oconto county are looking a joint tower for the communication issues. The lighting project at the department is now complete. The Town Chairman asked the chief for a report to be presented on Pfas that is used in the fire fighting foam.

Community Park: Mailings for the Community days will be going out to the Town residents. May 16<sup>th</sup> will be the scheduled park clean up day starting at 7 A.M. They will do some tree mulching and general clean up duties. The poured in Place was discussed for the playground area.

Bodart/Huetter, motion to approve the underlying fabric for the play ground area at a cost of \$1,450.00. Motion Carried.

Public Works Report:

- Preparation for the spring flooding will continue

Humane officer report: Deneys/Huetter, Motion to receive and place on file the report from the humane officer. Motion Carried.

Planning Committee:

- CSM for Robin Ct was reviewed the CSM changed from 5 lots to 4 and was recommended for passage by the board
- Bob Fischer was present to request permission to dig 2 ponds on his daughters property to use the clay in the manure pits that are being constructed
- The rezoning of parcel PI-520-5 was discussed and it was recommended that the board deny the request.
- Zoning Administrator Report a resident wants to erecting a home on 5410 Norway Dr while living in the old home and then raising the old home once the new home is built

The town of Chase water issue was discussed and the Chairman will send a drafted letter to the Chairman of the Town of Chase letting him know we will be monitoring the water issue so we do not negatively impact our town citizens.
