Bodart/Huetter, motion to approve and deviate from the agenda as needed. Motion carried.

Huetter/Bodart, motion to approve the minutes from the July 14th, 2020 Town Board meeting. Motion carried.

Supervisor Announcement: Supervisor Tom Huetter put in his resignation to the Town Board, after 40 years of service to the Town of Pittsfield Supervisor Huetter will be stepping down as of September 30, 2020.
