Rescue: The Rescue meet on March 22nd with all municipalities present, the General fund is at \$17,949.89 of that \$2,819.65 is earmarked for the first responders, \$11,384.11 is in the EMS FAP funds which leave a total of \$3,746.13 in the Fund balance. The Equipment fund balance is at \$100,466.47 with the Village Equipment fund payment not in yet. The first responders are trying to coordinate training with the fire department yet.
