Rescue: Meet on June 28<sup>th</sup> at 1PM all present except the Village of Pulaski and the town of Lessor, both were excused. The General fund balance is at \$17,278.49 with \$2,819.65 earmarked for the first responders and \$11,384.11 earmarked for the EMS FAT which leaves a balance of \$3,074.73 in the general fund. The equipment funds has \$103,235.98 which includes all of the communities contributions to the equipment fund. Bids were open for the seal coating of the parking lot with the winning bid going to Seal coat specialists for \$1,163.40 which includes stripping. Bullet proof vests were discussed for keeping on the squad and will be purchased.
