Rescue: The Rescue meeting was held on September 29th with representation from each municipality present. The General fund balance is at \$3,547.45 with \$2,319.65 earmarked for the first responders. The equipment fund stands at \$134,260.30. There was a \$200 donation with the board voting on adding to the Equipment fund. There were 70 runs in August, with an average time for response at 8 minutes and 02 seconds. Current financial balance is now in the positive thanks to the changes that were set in place. The department is looking into new radios for the first responders and will come back with a cost. The department received \$85,570 in ARPA funds to put toward a new Ambulance which cost approximately \$245,000. The preliminary numbers for the budget shows an increase per municipality of approximately \$5,300.
